# **IEM AWARD FOR CONTRIBUTION TO THE ENGINEERING PROFESSION IN MALAYSIA**

## **CRITERIA AND GUIDELINES**

### ***ELIGIBILITY***

Nominations for the award are to be made annually. Only Engineering achievements within Malaysia shall be eligible for nomination.

### ***CRITERIA***

To encourage interest in engineering and to recognize contributions to engineering in Malaysia and the award. The Award is to be presented to person(s) who has contributed to the advancement of engineering in Malaysia who has designed and/or constructed an original engineering device or system of merit and applicability to industry.

### ***NOMINATING PROCEDURE***

- Nominations shall be made through a Corporate Member of The Institution.
- Each member is restricted to one nomination per year.
- The nominee must be a Malaysian citizen or a permanent resident
- Have contributed to the advancement of engineering in Malaysia
- Each nomination shall be accompanied by a brief write up of the services rendered or contributions made or system designed and/or constructed together with relevant photographs for publicity purposes.

Nomination Form must be submitted not later than 30 September of each year. The submission requires one proposer and two seconders who must be Corporate Members of IEM.

### ***AWARD COMMITTEE***

The Awards Committee may refer to additional materials in considering the merits of the project. Four (4) copies (*two hard copies and two soft copies*) of supporting documentations including photographs shall be presented. The award shall be made by the Council upon the recommendation of the Awards Committee. Not less than two third majority vote of the Awards Committee is necessary for a recommendation of an award to be forwarded to Council. When presented to Council for approval a simple majority to approve the project would be sufficient. The Immediate Past President will be the Chairman of Judging Committee with the Technical Division's representative to be invited to the Judging Committee.

### ***THE AWARD***

The award is in the form of a metal plaque, a scroll and RM1,000 in prize money. The award shall be presented with due ceremony at an appropriate function of the IEM. The metal plaque would be in English and the certificate presented in Bahasa Malaysia.
