The **Inland Revenue Board (IRB)**, in collaboration with the **Malaysian Digital Economy Corporation (MDEC)**, has officially launched e-invoicing in Malaysia. The first category of taxpayers went 'live' with e-Invoicing on 1 August 2024. The primary intention of e-invoicing is to advance Malaysia's digital economy and to improve tax administration. All businesses are required to be e-invoicing ready by 1 July 2025.

Adopting e-invoicing will undoubtedly result in changes to the Accounts Receivable and Accounts Payable functions. Establishing a clear implementation strategy is vital to ensure the business's seamless adoption of e-invoicing. This webinar aims to provide information on e-Invoicing, shed light on the impact from a tax and legal standpoint, and discuss the next steps and considerations especially tailored for engineering practices.
