SUMOPSIS

VM is defined as a structured multi-disciplinary team approach to seek functional requirements of programmes, projects, products, systems, or services to enhance performance in achieving organizational goals and objectives. In Malaysia Government, VM has been integrated into public programmes and projects since the 10th Malaysia Plan (10th MP) from 2010 to 2015, sustained in the 11th MP, the 12th MP, and to be continued its implementation in the 13th MP (2026 to 2030). Present day, VM is widely applied and it has evolved through-out public agencies in the country. Multiple VM Study interventions are marked at appropriate timings within Strategic Phase, Technical Phase and Use Phase. Using VM structured and systematic process, the methodology provides robust and effective reviews on project solutions, promotes innovative and creative thinking in improving value. In VM, adopting value concept stimulates beyond typical 'quality-time-cost' objectives that enhance functionality and project performance.
