2. **Revised Terms & Conditions –**

  - b) For Spouse/Children/Parents/Siblings: Copy of Marriage Certificate / Birth Certificate (whichever is applicable) and a).

9. The sale of the vehicle is subject to further terms and conditions applicable between the hirer/buyer of the vehicle and our authorized smart Dealers.
